Environmental Impact Assessment Experience

Brian's initial impact assessment experience came in the 1980s while he worked as an impact assessment biologist for the BC government. This work included assessing the water and air quality impacts of industrial and municipal discharges, and reviewing the EIA reports for new industrial developments such as metal mines. Extensive experience was gained in designing and carrying out impact assessments at pulp and paper mills, the aluminum smelter in Kitimat, municipal sewage and solid waste discharges, emissions from the asbestos mine in Cassiar, and new gold and other major mining proposals in Northwestern BC. Brian also served as chair of the Monitoring Subcommittee of the BC Acid Mine Drainage Task Force.
